RESOLUTION 1: FEES AND SUBSCRIPTIONS

Council is asking you to approve

Why

Despite a period of high inflation and the increase required to cover removal of the Faculty and Community paywalls from 2024, the proposed 2025 main subscription rate increase has been kept low at 2.22% (or £10). This would mean that the proposed 2025 main rate is below what it would have been if it had simply been increased with general inflation over the period from 2018.

The proposed changes to eligibility for Life Membership reflect changes being seen in the ages at which some members are retiring from paid employment.

RESOLUTION 2: REMOVAL OF PRINCIPAL BYE-LAW 44 – EX OFFICIO MEMBERSHIP OF COMMITTEES

Council is asking you to approve

The removal of Principal Bye-law (PBL) 44 with effect from 1 January 2025 or such other later date as the Lords of His Majesty's Privy Council may determine.

Why

This bye-law is in contradiction with the recent amendments to the governance framework of ICAEW.

The bye-law has not been enacted for a number of years and, with the revisions to the composition of the Board and governance committees, the President, Deputy President and Vice President are no longer invited to be ex-officio members of all of these governance bodies.

In place of this bye-law, the governance framework allows for the President, Deputy President and Vice President to observe committee meetings.

RESOLUTION 3: PRIVY COUNCIL ALLOWANCE

Council is asking you to approve

That the Council be empowered to accept any minor alteration of, or addition to, the foregoing resolutions which may be required by the Lords of his Majesty's Most Honourable Privy Council as a condition precedent to the allowance of the proposals provided for by such resolutions.

Why

This resolution enables us to avoid unnecessary bureaucracy and keep costs to the minimum. We have to submit the changes to the Supplemental Charter and bye-laws agreed by members to HM Privy Council for approval. Occasionally, the Privy Council requires small changes of detail. This standard resolution allows us to accept these changes without calling a further Special meeting of members.
