A big thank you in particular to Julian, John and Andrew for taking such great care with this as it has involved a lot of time and effort, however I will leave Julian to touch further on this.

Whilst this has been going on behind the scenes, I am proud of that all of our regular member activities have continued to run throughout the District Society. In July we held our second students and young members BBQ with increased engagement with both.

We have connected with CABA to help focus on wellbeing and mental health in our profession.

This year, I have personally most enjoyed taking part in our new BBH one on one mentorship scheme working closely with students from lower socio-economic backgrounds from the University of Hertfordshire. Just last week I received an email from my mentee saying she had secured an ACA training contract at a local firm. Overall, I am most thankful for the opportunity to set up our women networking group, for the personal development that being a BBH volunteer provides but mostly for the connections and relationships I have built.

#### 9. Julian Daly, Incoming President's welcome speech: Good evening.

I promised Lucy to keep this short, so here goes.

I am Julian Daly, a member in Business.

For those who don't know me, I qualified with KPMG in London and spent a couple of years in their Long Island, New York office.

I then moved to be CFO of Oppenheimer International, a US investment bank's London subsidiary, spent a spell as Finance Director of a software business, before becoming Finance Director of Close Brothers' Asset Management Division

I am now at a spin off from Close Brothers, investing circa £0.7bn in UK commercial property for institutional client.

I have also been a member of the Hertfordshire Local Enterprise Partnership and Leader of St Albans City and District Council.

Last June I joined the ICAEW's Council as one of your representatives.

Unusually I have already had the honour of being your President. I took over from Andrew Williamson in October 2020 and stood down in May 2021 after a period much impacted by Covid.

So why am I here again?

Most of you will be aware that like the Thames Valley and South East District Societies, we have voted to remain an independent Society. Your Management Committee expect there will be some turbulence as we and the ICAEW work out exactly what this entails.

For example, we are still negotiating our Service level Agreement with the ICAEW team.

I put myself forward to help steer the Society through that turbulence and hopefully set things up for a clean handover to Ben this time next year. If nothing else, I know my way around the ICAEW better than I did the first time around.

When I first stood up to be your President, I set out my take on our "sense of purpose".

I do not think that this has changed and see it as being:

- to act as a link between ICAEW strategy and its members;
- to provide Continuing Professional Development (physical, more than virtual);
- to put on events & networking opportunities;
- to promote the Chartered Accountant qualification.

Despite the 'independence' vote, we remain the ICAEW's boots on the ground. So, I will support continued delivery of our programme of training and events while we sort out a more arm's length relationship with the ICAEW.

Ben, Simba and I plan to work together to roll forward the Society's existing 3 year plan.

If you have ideas on new events we should put on, or ways we can improve what we do, please do not hesitate to let me know.

Finally thank you to Lucy for her successful year as President and a big thank you to Kim Shield for her years of excellent support to all of us as members.

I look forward in working for and with you.
