In addition to the above, the Officers of the Society, the immediate Past President and a member of the Council of the Institute of Chartered Accountants in England and Wales, who are also members of this Society, are members of the Committee.

Review of the year

The committee are in the process of transitioning to a ICAEW Community status from the 1st January 2023, with all future activity performed under the new set-up. Most of LANSOCA activity will be paused, with only discretionary funding support provided for member activities.

In 2022, the society's activities remain reduced since March 2020 pandemic, with very little activity occurring. Income from training courses for 2022 was £223 from the Practitioners Essentials - District Society commission and with the cancellation of the Topical Tax Tips course resulted in a cost of £563. The Society receive annual income from an ICAEW contribution of £1,500 to cover the Society's administration costs and £2,000 towards various society event. This funding will cease with the organisation change in 2023.

The combination of the Institute's grant, the focused income/expenses from the courses and the movement in various costs, have lead to a deficit in income over expenditure for the year of £900.

Risk review

The Society's Rules require that the Officers prepare accounts of the Society for each financial year. Under the Society's rules, the accounts are required to be examined by an independent accountant and copies made available to members.

In preparing these accounts, the Officers and Committee have:

- selected suitable accounting policies and applied them consistently;
- made judgements and estimates that are reasonable and prudent;
- followed the recognition and measurement requirements of applicable UK Accounting Standards; and
- prepared the accounts on a going concern basis.

The Officers are also responsible for keeping proper accounting records that disclose with reasonable accuracy the financial position of the Society. They have a general responsibility for taking such steps as are reasonably open to them to safeguard the assets of the Society and to prevent and detect fraud and other irregularities.
