

BENJAMIN MEE, OWNER OF DARTMOOR ZOO ANNOUNCED AS ANNUAL DINNER GUEST SPEAKER

In the midst of chasing escaping Jaguars and adolescent vervet monkeys, his wife's brain tumour returned. The prognosis was poor, and so Ben found himself juggling the complexities of managing a zoo and getting it ready for re-opening while facing the consequences of his wife's terminal illness and caring for their two young children. In 2012 his story was made into a film starring Matt Damon and Scarlett Johansson. The zoo and Benjamin have also featured in the BBC Two documentary Ben's Zoo as well as the CBBC series My Life.

FEMALE FORUM HELPING YOU WITH THOSE UNCOMFORTABLE CONVERSATIONS



This is a great opportunity to meet other members based within Devon, Cornwall & Somerset.



ALL TOO FAMILIAR – ICAEW ANTI-MONEY LAUNDERING TRAINING FILM

All Too Familiar is launching next month and a link to the film along with copies of supporting materials will be emailed to regulatory contacts (eg, the money laundering reporting officer or compliance principal) at ICAEW supervised firms.

The film has been created by ICAEW in collaboration with HMRC. It explores the degree of trust still placed in personal and professional relationships and whether enough scepticism

is being used in the fight against economic crime.

As well as professional scepticism, *All Too Familiar* draws out many themes for discussion, such as whether familiarity has clouded the firm's judgement, how and when to disengage from a client and a firm's professional responsibilities when engaging with law enforcement. It also examines the appropriate levels of Customer Due Diligence (CDD) and risk assessments for client relationships.

HAPPY NEW YEAR!

As part of the reflection, I thought I would share some facts and figures from an ICAEW point of view about 2021 - our second year of adapting to Covid. Quite surprisingly it has been a record year for student intake for our qualifications with over 11,000 individuals starting their accountancy journey. In addition, ICAEW membership has increased by over 4200 members - bringing the total membership worldwide to over 161,400! Within the ICAEW South and South West region we have met or talked to nearly 4000 individual members during 2021 which is a significant increase on 2020. The use of virtual meetings and events has really overcome the geography of the area and allowed members to meet more regularly. So actually, a very positive year.


As I write this at the beginning of 2022, announcements around infection rates on the Omicron Covid variant seem to be reducing. Although the pandemic is nowhere near over, it does give us hope of being able to meet more freely face to face. 2022 I can see will be a year of weighing up what is the most appropriate way of meeting or attending an event. RISE INITIATIVE LAUNCHED: ICAEW LEADS ON SOCIAL MOBILITY PLAN

In December, ICAEW launched a new programme called Rise, which will teach communication skills, problem-solving and teamwork to young people in schools across the country. The programme has been set up to raise the aspirations of young people from low socio-economic backgrounds. Research from the Social Mobility Foundation suggests that a young person is twice as likely to become an accountant if their parents are accountants. Young people with no access to accountants through their parents' networks may not consider our profession as the rewarding career that we all know that it is. Thankfully our profession seems to be doing better than some others – a person is 24 times more likely to become a doctor if one of their parents is a doctor and 17 times for lawyers.

There are lots of talented young people out there and we need make sure that they consider accountancy as a career and this will widen the pool from which we can recruit. Young people don't know what they don't know and will naturally not think about being an accountant if they don't understand what accountants do. They do have aspirations as well as being talented and we can help them. Social mobility cold spots include costal and rural areas of which we have plenty in the South West.

ICAEW has teamed up with not-for-profit The Talent Foundry to deliver sessions in schools. Their staff will go through seven steps in a one-day session. These include how to use language, working with numbers, decision making and analysis. But we need your help. While The Talent Foundry will provide people to facilitate the learning we need accountants to be in the room to be a voice that is not their teachers' or parents'. While we may not perceive ourselves as being particularly inspiring, having someone give up their time, go to a school and show interest in the young people is inspiring for them. Any of us with children may have experienced how they don't listen to us, just because we're their parents, so having a new role model can be very important.

The Talent Foundry will provide support prior to the session and this can be a great opportunity for a more junior member in your team to develop themselves.
